



Waiver and Indemnity Form

I warrant that I am in good health and have no physical condition that would endanger my life while participating in the activities of the **Singapore Paddle Club (“SPC”)**.

I understand that participating in the activities of SPC carries with it the inherent risk of physical injury, including serious injury such as permanent disability, paralysis and even death and in undertaking such activities I do so at my own risk.

I am also aware that it is a condition to my participation in any event that SPC, its officers, employees, representatives, agents, volunteers, instructors, members, or servants are absolved from all liability howsoever arising from injury or damage howsoever caused (whether fatal or otherwise) arising out of my participation in an event or in training, instruction or carriage in any vessel being used for or in connection with dragon boat/outrigger canoe racing or in any way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of SPC, its respective officers, employees, representatives, agents, volunteers, instructors, members, or servants.

I am also aware that any person participating in dragon boat training, dragon boat racing, outrigger canoe racing, learning to outrigger, training or being involved with any vessel being used for or in connection with dragon boating or outrigger canoe racing or participating in any activity carried out by SPC are only allowed to do so on the distinct understanding that they do so at their own risk.

I am also aware that all boats, equipment and other personal items are stored at my own risk and do not hold SPC responsible for any theft, damage or loss. This agreement shall be binding upon and inure to the benefit of the parties, their successors, administrators, assigns and personal representatives in consideration of being allowed to participate in the activities of the SPC, which includes training for and participating in regattas.

In consideration of SPC allowing me to participate in its activities, I undertake that if, in the course of such activities, I deliberately or negligently cause any injury (whether fatal or otherwise) to any person or any damage to or loss of any property of any person, I shall indemnify SPC if that suffering person makes claims or takes actions against SPC or SPC has to pay for costs or expenses.

I ACKNOWLEDGE that I have read and understood the warning and indemnity above and agree to release and forever hold harmless from any liability, suit or action howsoever arising SPC and its respective officers, employees, representatives, agents, volunteers, instructors, members, or servants in the event of my injury and/or death. I represent that I am at least 18 years of age; or if I am under 18, my parent or legal guardian has agreed to the terms of this Indemnity Form.
