



**INDEMNITY AND RELEASE FORM**

I understand that participating in the activities of the Paddle Club (Singapore) (now referred to as 'SPC') carries with the inherent risk of physical injury, including serious injury such as permanent disability, paralysis and even death and in undertaking such activities I do so at my own risk.

I am also aware that it is a condition to my participation in any SPC event that SPC, its officers, employees, representatives, agents, volunteers, instructors, members, or servants are absolved from all liability howsoever arising from injury or damage howsoever caused (whether fatal or otherwise) arising out of my participation in an event or in training, instruction or carriage in any vessel being used for or in connection with dragonboat/outrigger canoe training or racing or in any way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of SPC, its respective officers, employees, representatives, agents, volunteers, instructors, members, or servants.

I am also aware that any person participating in dragonboat training, dragonboat racing, outrigger canoe training, outrigger canoe racing, outrigger canoe instruction or being involved with any vessel being used for or in connection with dragonboating or outrigger canoeing or participating in any activity carried out by SPC are only allowed to do so on the distinct understanding that they do so at their own risk.

This agreement shall be binding upon and inure to the benefit of the parties, their successors, administrators, assigns and personal representatives.

In consideration of being allowed to participate in the activities of the SPC, which includes training for and participating in regattas, I .....
